

Springbank Aquatic Center 2017 Membership Agreement

This Agreement between Springbank Homeowners Association, c/o: Property Specialists, Inc. 1005 Internationale Parkway Suite 204, Woodridge, IL 60517 and Membership Applicant(s) has been established to assure all parties are aware of all guidelines and the rules and regulations pertaining to the Springbank Aquatic Center. Complete the agreement and bring with you on the day of registration.

The following guidelines have been created for the 2017 swim season:

- The Springbank Aquatic Center is scheduled to open Saturday, May 27, 2017, and close on Monday, September 4, 2017. The general hours are 11:00am to 8:00pm. Please refer to the Springbank Handbook for the exceptions to the availability of dates and hours.
- Family Membership is defined as all family members who permanently reside in your household address. All extended family members must pay guest pass fees per visit.
- Caregiver Memberships are available for Caregivers to family members of the Membership holder. This fee is an additional \$50.00 per Caregiver.
- Guest Passes will be available on a daily basis at \$6.00 per full day, or \$3.00 after 4:00pm. When using a Guest Pass, Guest must be accompanied by Member, and a Guest Release, Waiver of Claim and Indemnification Agreement must be signed. For children under 18 years of age, the Guest Release must be signed by their Legal Guardian prior to admission.
- Photo ID Membership Cards will be provided to all Residents, and must be presented to gain access to the Aquatic Center. All members must get a new photo ID card for the 2017 season. Dates will be determined to have photo processed and member cards distributed. **PROOF OF RESIDENCY MUST BE PROVIDED FOR ALL MEMBERS AT THAT TIME PRIOR TO RECEIVING MEMBERSHIP CARDS.** Adults can submit driver's license or state ID card, any utility bill or check showing member's name and address. For children, member will need to show a copy of school records, insurance card or birth certificate.
- Aquatic Center memberships will be dispensed on an annual basis and are non-transferable. The number of annual non-resident memberships available will vary from year to year, and will be determined by the Springbank Homeowners Association.
- All Members must follow the Springbank Aquatic Center Handbook, Rules and Regulations or risk loss of aquatic center privileges, with no refund of annual dues. The Homeowners Association or the management company also has the right to deny your entry in following years.
- Any misleading residency information provided during membership sign up will result in the loss of aquatic center privileges, with no refund of annual dues.
- Minimum height for the use of water slides is 48".

Each of the undersigned, for and in consideration of permission to enter upon the premises of the SBAC and participate in its inherently hazardous aquatic activities, and other good and valuable consideration, the sufficiency of which is hereby acknowledged, do hereby voluntarily assume all risk of loss, damage, or personal injury, including death that may be sustained by any or each of the undersigned which may hereinafter occur on account of, or in any way grow out of the use of the SBAC.

The undersigned, for his or herself and for the minors named below, further expressly understands and agrees to release, acquit and forever discharge the Springbank Homeowners Association, Property Specialists, Inc., and any of their Officers, Directors, Agents, Employees, or any of their successors or assignees, of and from any and all actions, causes of action, claims, demands, damages, costs, expenses and compensation on account of, or in any way growing out of, injuries claimed to have been received by the undersigned or the minors named herein by reason of his, her, or their presence at or use of the SBAC; and further acknowledge and understands that in the event an undersigned adult has signed on behalf of a minor named herein and a suit or claim is filed by or for such minor against the aforementioned entities arising out of such minor's presence at or use of the SBAC, the undersigned adult will indemnify, hold harmless and defend the aforementioned entities in such action. All of the undersigned adults shall be jointly and severally liable for said indemnification and defense.
